Rick Bush discussed the Dick Schieffer preliminary plat. Once the document is filed, Dick will be annexed into the city and we will be providing City Services.

Cindy Ferguson was present to discuss the flushing of fire hydrants. Discussion centered around better communication between citizens regarding dates and times for flushing of hydrants. Discussed putting on the water bills, web site, in the newsletter, and radio station the dates and times of the flushing in the future.
