5	The Employee Relations Assistant reviewed the proposed Jail Administrator Position Description with the committee and reported that the JD was sent to legal for a legal opinion and it was confirmed that the position qualifies to be outside the union. Sheriff Michek covered a few changes that legal suggested and he agrees. Ms. Leitzinger reported that Carlson Dettmann provided a salary range for the position on grade 10 of the existing management/non-represented pay plan. They chose to do this as the Board has not seen or adopted a new plan yet. Motion by Gollon seconded by Peterson to recommend adopting the position description and pay grade as recommended by Carlson Dettman and legal and advertise this position at grade 10 of the existing management/non represented pay plan at a range of \$47,068 minimum to \$53,792 midpoint and it is to be budget neutral.
