1	Call to order. Supervisor Mrozinski called the meeting to order at 6:00pm.

5	<p>Supervisor Demby informed the commission that Tri-county airport manager Mark Higgs offered assistance to Iowa County if needed throughout this transition.</p> <p>Dan Spurley informed the commission that he has spoken to a lawyer and they are bringing a lawsuit against Cory Johnson and Iowa County Airport. Dan's property is within the class E airspace which Mr. Johnson continues to perform aerobatic maneuvers over. This has disturbed his cattle for some time and he doesn't know what else to do. Mr. Spurley also has a petition signed by his neighbors to stop the aerobatics.</p> <p>Christen said that there have been multiple complaints against Cory Johnson.</p> <p>Dennis Coogan commented on how appreciative he is of what Kevin King has done for the Iowa County airport and wanted to thank him for all he has done. Mr. Coogan doesn't want the negative actions at the airport to go too far but wants to focus on the positive stuff.</p>	
6	Motion by Benish, 2nd by Demby, to recommend Mark Meives to the County Board for approval to serve on the Iowa County Airport Commission. Motion carried.

8	Motion by Walmer, 2nd by Christen, to approve the new hangar lease for Archer Aviation, Hangar (14). Motion carried.	
9	Cory Johnson was not present to discuss this topic.	
10	Cory Johnson was not present to discuss this topic, but Christen gave a discription and history of Class E airspace at the Iowa County Airport.	
11	David Platt's hangar lease termination documentation is still in progress and there is no further update at this time.	
12	The commission had a discussion on the future management at the Iowa County Airport. The commission is certain that the airport will not run itself and must have proper management. Christen
