The DNR has finally closed out the 2012-2013 bridge rehabilitation grant as Tom was able to find and submit archived invoices in the amount of the grant funding avoiding repayment of any of the Grant money that was received.

b. Status of FEMA grant money from July flooding. Tom reported that he and Lee McCarville had met with the FEMA team and explained the damages that occurred along the Cheese Country Trail. A declaration has been requested by the Governor, and the County is waiting to hear if money will be made available.

Craig Shager reported that the Green County Clubs had to add some breaker run and gravel to portions of the trail following the flooding of July19-21, and had to grade their portion of the trail. Lee also reported that there was quite a bit of wind damage from July 19<sup>th</sup> along with several areas of washouts that had to be repaired following the flooding of both July 19<sup>th</sup> and 21<sup>st</sup>.
