Joe addressed the calendar events format for the 2018 guide. Paul made a <u>motion</u> to limit each event description, have a spreadsheet by county for review and include a disclaimer for calendar of events for the 2018 guide. Bob B. seconded. Motion carried.

BOOK COUNT / SALES REPORT

Dave reported that Iowa County is down to 10 cases in storage and 4 cases in his vehicle. He will need more guides before fall. Almost all of Dave's existing advertisers were able to take advantage of the early bird discount. Randy has 10 cases of guides in both Grant County and La Fayette County. Randy also has several advertisers interested in receiving racks to display Hidden Valleys guides.

NEW BUSINESS:

Ron B. made a <u>motion</u> to transfer \$200 from checking into savings for a prudent reserve at the end of every fiscal year as funds allow. Bob S. seconded. Motion carried.
