## **Iowa County Justice Committee Meeting**

May 4, 2010 @ 6:15P.M.

- The Iowa County Justice Committee met on May 4, 2010, in the Iower conference room, at the Iowa County Sheriff's Department. Meeting was called to order by Iowa Co. Board Chairperson David Bauer.
  - **a.** Roll Call: All members were present.
  - **b.** <u>Certification of Meeting:</u> Anderson made motion, seconded by Thomas. Carried.
  - **c.** <u>Election of Committee Chairperson</u>: Nominations made for Anderson, Mroziwski, and Thomas. Votes counted, and Anderson selected
  - **d.** <u>Election of Committee Vice-Chairperson</u>: Nomination made for Hiltbrand and Mroziwski. Votes counted, and Mroziwski selected.
  - **e.** <u>Election of Committee Secretary</u>: Nomination for Chief Dep. J. Pepper. No other nominations. Pepper selected.
  - f. Approval of Agenda: Mroziwski made motion, seconded by Weaver. Carried.
  - **g.** Approval of Justice Committee Minutes from April 6, 2010: Parman made motion, seconded by Hiltbrand. Carried.
  - h. <u>Open Session- Comments from Audience/Committee members</u>: Introduction of all Committee members, and Dept. Heads present was made. Parman asked about the status of the revised "Noise Ordinance". Anderson stated the matter would be placed on the June agenda for review and discussion. Anderson thanked the Emergency Mgmt. Director for obtaining the Radio Grant.
- 2. <u>Clerk of Court</u>: Gave update on Family Action Booklet fees, and stated that Judge Dyke was very supportive of the new fees, and also that if citizens did not have the means to pay for the booklets, that the fee was waived.
- 3. <u>Child Support</u>: Gave an update to the Committee on her department receiving the State's 2009 Performance Award; which was based upon four (4) separate categories. Iowa County Child Support had excelled in all four categories.
- 4. <u>Emergency Management</u>: Report was given (see attached document). Discussion was also made on the "Suspension of Government Operations" policy. County Admin. Kephart gave his

professional opinion that such a policy is needed for Iowa County. Anderson directed that Committee members review the policy, and direct their questions to the E.M. Director, and would be placed on future agenda for further discussion, and possible action.

- 5. **Sheriff's Department**: Status given on pending grievances, and employment update. Discussion also on the "Communications Assessment from RCC Consulting". The new committee members were encouraged to obtain a copy of the assessment plan from the County Clerk's office, and review for future discussion.
- 6. **Next Meeting**: The next Justice Committee meeting will be held on June 1, 2010 at 6:00P.m. \*\*\*
