

Iowa County Justice Committee Meeting

Minutes

The Iowa County Justice Committee met on June 1, 2010 @ 6:00p.m. In the lower conference room, at the Iowa County Sheriff's Department. The meeting was called to order by Ms. Carol Anderson, Chairperson for the Justice Committee.

1. Roll Call: Present were: Anderson, Parman, Weaver, Hiltbrand and Zinck. Excused: Brunker, Thomas, and Mrozinski. Late: Kephart and Bauer advised the Committee Secretary they would be late. * Bauer arrived at 6:45p.m. Kephart arrived at 7:27p.m. *. Also present: Jon Pepper, Keith Hurlbert, and Judge Dyke.
2. Certification of Meeting: Motion by Parman, seconded by Hiltbrand. Carried.
3. Approval of June 1, 2010 Agenda: Motion by Zinck, seconded by Hiltbrand. Carried.
4. Approval of May 4, 2010 JC meeting minutes: Motion by Parman, seconded by Zinck. Carried.
5. Open Session: No comments made from Committee members, or audience.
6. Information on the Department of Court Ordered Programs: Anderson advised that she was in receipt of a letter of resignation from Marcia Richgels, which is effective July 1, 2010. Judge William Dyke was present to discuss the Court Ordered Programs. Discussion held on which Dept. should oversee these programs. Matter will be referred to County Admin. Kephart.

7. Emergency Management:

- Review of "Suspension of Government Operations Policy". Discussion held. Weaver then made motion to accept version #5 and have issue sent to Administrative Services Committee for further review and action. Seconded by Parman. Carried.
- CDBG-EAP Grant award: Iowa County will be receiving an additional \$250,000.00 grant for past flood relief. Advertisements will be placed in several area newspapers. Program will be monitored by Southwest Cap office.
- Monthly report given (see attached).

8. Sheriff's Department:

- Status on Grievances: Matters are still pending with the Union and County.
- Review and possible action on the communications assessment by RCC Consulting: Discussion held. Issue will be tabled until a "Special Board Meeting" can be held for approx. one hour, in which RCC Consultants will give brief overview.
- Review and possible action on updated "Noise Ordinance". Discussion held. Issue will be tabled until the August 2010 JC meeting for further discussion and possible action.
- Sheriff's Employment Update: New Jailer/Dispatcher hire is doing excellent job on his in-house training. Also informed Committee that a patrol deputy will be resigning to take new position with DNR. Will be looking to fill vacancy.
- Advised the Committee that many of Wisconsin Counties are now adopting the State's "Smoking Ordinances". Issue is to be forwarded to June Meudt and Health Dept. for further review.
