Godfrey reviewed the revisions made to the Farmland Preservation Program (not called the Working Lands Initiative) and Chapter 91 Statutes as included in the adopted state budget. The focus of the discussion was on how to address the required zoning conversion fee to be effective January 1, 2010.

Godfrey was provided direction to analyze the feasibility of creating a general agricultural district that would not be considered an "agricultural preservation district" for the purposes of the Working Lands Initiative and whether those landowners currently zoned A-1 Agricultural can be polled for interest in remaining A-1 or being zoned to the new district.
