Ehr asked if the request was in compliance with the existing town moratorium on land divisions. The Town responded that it was in process before moratorium began.

McGuire asked if the easement could be relocated so as not to divide the proposed lots. The Town and applicant stated that it is proposed as is in order to avoid developing "prime soils" as defined by town ordinance.

Ehr stated that an anonymous source called and stated that this petition is only to increase the value of the property and that it was being looked at by The Nature Conservancy. Ihm responded that this is true but having the lots would be a "back up" plan if the Conservancy does not buy.

Bill Ehr stated the countywide groundwater currently underway supports casing private wells in this area to about 130 feet or into the St. Peters Aquifer. Ehr asked the applicant if he would be willing to require this within the covenants. McKenzie agreed.

Bunker asked the applicant if he would be willing to pay for improvements to the intersection of the town road and USH 18/151. McKenzie declined.

Motion by Dwayne to approve on condition that the preliminary plat is approved. Second by McGuire Motion 3-2 Bob Bunker and Bill Ehr voting against.
