3. Certification of notice for this meeting. Godfrey stated this meeting has been duly noticed and posted as required by law.

5. Approval of agenda

6. Consideration of amendments to the Iowa County Address Ordinance with focus on compatibility with the county's E911/Computer Aided Dispatch system.

Issues were discussed and direction given for the further revision of the ordinance draft on the following:

- a) Centerline vs point addressing for CAD
- b) Addressing public and quasi-public locations
- c) Addressing utilities
- d) Public outreach/education
- e) Coordination of systems with cities & villages
- f) Sign specifications
- g) Sign placement specification
- h) Authority to order sign replacement
- i) Strategies for countywide replacement with new signs
- j) Addressing multi-unit buildings
- k) Like-sounding and duplicate road names
- l) Naming shared driveways

Godfrey is to take the suggestions and prepare a revised draft for review at a future meeting.

7. Consideration of permitting policy for public road projects under the provisions of the county's floodplain and shoreland/wetland ordinances.

Godfrey handed out a draft policy that would exempt certain projects from permitting requirements, provided the necessary data on impacts to the floodplain is provided to the office.

8. Consideration of contribution toward stormwater and erosion control educational folders.

Godfrey summarized his involvement in a multi-jurisdictional educational effort facilitated by the UW-Extension on the impacts to water resources by stormwater and erosion. The effort is producing folders with educational information that will be provided to property owners. The next effort will be to consider workshops targeting local officials to educate on stormwater and erosion control regulations...what are they, what exists and are more needed. He asked if the Commission would like to support this effort with any funding to cover material costs, citing the Land Conservation Committee has pledged money already.
