- **1. Meeting Called to Order-** at 12:58 p.m. by Chairman Leon Wolfe, at the Community Townsend Center, Shullsburg, WI 53586
- 2. Roll Call- Iowa County Board: Marjorie Bomkamp and Dan Nankee. Absent Jeremy Meek. Lafayette County Board: John Bartels, Leon Wolfe and Carol Korn. Others Present- Cecile McManus, Executive Director; Jay Loop, Financial Asst., Valerie Hiltbrand, ADRC Iowa County; Bob Schroeder, ADRC Lafayette County.
- **3.** Certification of Compliance with Open Meeting Law- McManus stated that on Wednesday August 16, 2017 prior to the meeting, the agenda was posted at the HHS Building and via email to-Iowa County: The Dodgeville Chronicle and Deputy County Clerk. Lafayette County: The Republican Journal, County Clerk, and Deputy County Clerk. Chairman Wolfe requested the records show that the meeting was properly posted.

with the help of AARP, in Darlington. **b**.) Hiltbrand advised Brittany Mainwaring had her baby. Nikki Brennum is now back fulltime. They will start interviewing for the Dementia Care Specialist position. Stepping On (Prevention Program) starts Thursday, 8/17/17, at Upland Hills Hospital. The Aging and Disability Network Conference will be held September 6-8th in Madison. Hiltbrand wrote a grant for a new van to aid with rural transportation.

- **8. Monthly reports-possible action- a.)** Cash Flow Statement showed beginning balance on July 20, 2017 of \$27,086.26, donations of \$31,065.97, with total deposits of \$42,508.07 minus total vouchers of \$54,673.14, leaving an ending balance of \$14,904.19. CD's showed interest of \$3.15 added, making new total of \$83,549.66.51. **b.)** Budget Reports-the month of July showed total income of 37,260.78 and total expenses of \$55,181.20 leaving a net decrease of \$\$17.920.42. YTD shows a net decrease of \$48,683.74, mostly the result of the GWAAR funding allocation.. **c.)** Monthly Participant Numbers for July showed 3873 meals were served. Total donations received were \$31,065.97. Dodgeville, Argyle and Belmont remain strong. Arena, Shullsburg and Benton are showing signs of doing much better. Motion to approve reports was made by Bomkamp. Seconded by Bartels. Motion carried.
- **9. Sick Leave Policy X1X.J;Vested Sick Time-possible action-**after discussion, Korn made a motion we leave it as is. Seconded by Bartels. Motion carried.
- 10. Staff and Site Issues/Reports-possible action-McManus advised they interviewed two cook candidates for the Shullsburg opening. McManus will check references and do background check and make a decision. Margaret Hentrich, Belmont site Manager will be retiring at the end of year.
