#4	This item was struck from the agenda because Corporation Counsel Allen was not present.	Corp Counsel opinions
#5	The committee and advisory panel began review and discussion of the ordinance from where we ended at the last meeting. Discussion started with section 2.1 K. Security. After some discussion on security being in the ordinance or application. The draft was struck and replaced with "The arrangements and costs are the responsibility of the event organizer." There will be a place on the application for the organizers or county officials to request or require services. All but the second sentence of L. were struck from the draft. Under item M. the consensus was that volunteers should only direct participant traffic and sheriffs will take care of other traffic. Corporation Counsel needs to check on this item. Course markings were discussed. Township and county officials do not want paints or chalk on the roads; certain types can remain for long periods of time and can become crowded or confusing on routes that are frequently used. Stuart said that standing signs get vandalized, turned the opposite way and stolen. They are also expensive and take more time to set up and take down. He offered route arrows, which are stickers that are biodegradable. Items b. thru l. were struck from the draft and Commissioner Hardy is going to put route arrows into the next draft. Item O. ties in with item A. and was struck from the draft. Item P. was left in but the language will need to be edited. Item R. is similar to security. The wording was changed and the organizer can request or the county can require extra-ordinary services. Discussion the moved to section 2.2 Permits and Fees. The first sentence was struck under item A. Items B and C were left in. Items D and E were struck from the draft and can be addressed in permit review and section 2.3 B. Item F will now read "Applications must be submitted a minimum of six(6) weeks prior to the occurrence of the event but no earlier than January 1 of the event year. 	draft. A checklist would be the preferred method to make sure applications are complete before they are submitted. Route plans need to be submitted with the application but can be changed if necessary. These items will be typed into the second draft and the committee will vote on the whole final draft to put forward to the full board.
