- 1) Review of bids from 03/06/2006 for One (1) New Tri-Axle Truck Chassis. Motion by Masters to accept Peterbilt's bid of \$89,929 for a 2007 Peterbilt, Manual Transmission, 357 Model, 385 HP, Cummins ISM Engine, with delivery date in June of July 2006. Motion seconded by Clifton. Motion passed unanimously.
- 2) Review of bids from 03/06/2006 for truck equipment. Wunderlin made a motion to accept the Madison Truck's bid of \$57,856.00. This bid consisted of \$3,756 for a 2006 Swenson Tailgate Sander with 6" Auger, SAD SS Model; \$6,225 for a 2006 Universal 9' Snow Wing (Right Wing), 9' PDF/AHW Model; \$8,109 for a 2006 Universal 11' Snow Plow; and \$39,766 for a 2006 Brandon tri-axle dump body. Motion was seconded by Clifton. Motion failed 3 to 2. Nos were Masters, Theobald, and Thomas. Yeses were Clifton and Wunderlin. Thomas made a motion to accept TEAM Marshfield's bid of \$58,000. Motion seconded by Masters. Motion passed unanimously. This bid consists of \$3,675 for a 2006 Swenson

Tailgate Sander with 6" Auger, SBD-6S-S3 Model; \$6,160 for a 2006 Universal 9' Snow Wing (Right Wing), AHW PDF9 Model; \$7,100 for a 2006 Universal Reversible 11' Snow Plow, BH-11-43L Model; and \$42,800 for a 2006 Bibeau Tri-axle Dump Body, BFLSAT Model. The total bid totals \$59,735.00, however if the entire equipment package is purchased through TEAM Marshfield the bid is lowered to \$58,000.00.

- 3) Review of bids for 2006 Road Oil at 10:00 a.m. The following were present for the Road Oil bids: Bill Lawton of Henry G. Miegs, LLC and Bob Riutta of Flint Hills Resources, LD. The following bids were taken; Koch Materials of Dubuque, IA (Flint Hills Resources, LD) had no bid for the MC Type, 500 Grade, no bid for the MC Type, 250 Grade, \$285.34 per ton for the PG Type, 64/22 Grade, \$285.34 for PG Type, 58/28 Grade, \$1.0937 cents per gallon (\$259.21 per ton) for Emulsion, CRS2 Grade, and \$1.2137 cents per gallon (\$287.65 per ton) for Emulsion, CRS2 applied. There is no demurrage schedule, one hour free time loading, with a charge of \$60.00 per hour over free time. Henry G. Miegs, LLC bid \$1.7013 cents per gallon for MC Type, 500 Grade, \$1.7013 cents per gallon for MC Type, 250 Grade, \$282.06 per ton for PG Type, 64/22 Grade, \$282.06 per ton for PG Type, 58/28 Grade, \$1.0413 cents per gallon for Emulsion, CRS2 Grade, and \$1.1613 cents per gallon for Emulsion, CRS2 applied. There is an unlimited demurrage schedule, unlimited free time for unloading, and no charger per hour over free time. Thomas made a motion to accept all bids. Motion was seconded by Wunderlin. Motion passed unanimously.
