Authorizing an Agreement with the Thousand Islands Regional Tourism Development Corporation for the Provision of Public Benefits Services for Promotion and Publicity and Amending the 2013 County Budget in Relation Thereto

By Legislator:

Resolved, That, pursuant to Sections 224 and 225 of County Law, the County shall enter into a contract with Thousand Islands Regional Tourism Development Corporation under the following terms and conditions:

- 1. In addition to those services provided to the County pursuant to Resolution 15 of 2013, the Corporation shall provide the County with the following special services in 2013 in accordance with a proposal provided by it dated April 4, 2013:
 - A. It will promote the Jefferson County Wine Trail at a cost of \$25,000;
 - B. It will obtain high definition video and photography of County tourism highlights at a cost of \$25,000;
 - C. It will provide additional promotion of County fishing resources at a cost of \$40,000 leveraging an additional \$60,000 in State funds;
 - D. It will promote County historic sites at a cost of \$10,000, leveraging an additional \$100,000 in State funds; and
 - E. It will facilitate marketing outreach to business and leisure air travelers in Eastern Ontario and the border region to broaden the awareness and utilization of the Watertown International Airport at a cost of \$50,000.
- 2. The amount to be paid from County funds shall not exceed One Hundred Fifty Thousand Dollars (\$150,000) for the term of this agreement.
- 3. Payment shall be made by the County Treasurer in the sum of \$150,000 on or about July 1, 2013, said payment contingent upon receipt of a Memorandum of Receipt duly executed by the principal officer and disbursing officer of the Corporation in which they, on behalf of the Corporation, agree to comply with the terms of this resolution.
- 4. The term of this Agreement shall be from May 1, 2013 through December 31, 2013.
- 5. Within thirty (30) days of the termination of this Agreement, the Corporation shall provide and render to the County a verified account of the disbursements of such organization with verified or certified vouchers therefor attached. The County Auditor, in her sole discretion, may request such verified accounting be rendered to the County each quarter during the term of this Agreement.
- 6. The Corporation shall refund to the County at the termination of this Agreement, any

monies paid by the County remaining unobligated.

- 7. On or before the 1st day of January 2014, and at any other time as the Board of Legislators may request, the Directors of the Corporation shall report in writing to this body a detailed statement of work and transactions for the preceding year, and for any other period which this body may request, in such form as it may direct.
- 8. Such other terms and conditions as the parties may agree to in writing, and be it further

Resolved, That upon execution of the Memorandum of Receipt, as specified in the statutes, this Resolution, the Memorandum of Receipt and such other addenda as may be agreed to by the parties, shall comprise the contract between the County and the Corporation, and be it further

HD Aerial Stock Footage (\$25,000)

The goal of this project is to capture a significant amount of high definition video footage of attractions and scenic areas in 1000 Islands Region, including the Lake Ontario Shore, St. Lawrence and inland areas.

The Council will participate with other partners in New York and Ontario with the goal of engaging a specialized helicopter and videography crew to produce this national broadcast quality footage. In total, three days of shooting will carry a price tag in the \$75,000 range, with \$25,000 coming from the special allocation.

For the Council, the result will be hours of "b-roll" or footage that can be edited into many productions. The Council will use it in its TV ads, as well as in various on-line videos. It will also provide it to media working on stories about the region. Further, it will be made available to non-tourism organizations wishing to make promotional videos that include aerial footage. With the transition to HD over the past few years, older video footage of the area is out-of-date for current production standards.

Fishing Promotion (\$40,000)

The Council was awarded a \$60,000 grant by Empire State Development against at \$100,000 project to create and promote a series of short (3-5 minute) videos about fishing in the North Country, along with other internet "content" about fishing (photos, stories). The goal is to create 20 shorts covering topics such as "Charter Fishing from Henderson Harbor"; "Chasing Trophy Muskies on the St. Lawrence"; or "Discover the Indian River Lakes."

Once produced, the videos would be posted to a YouTube channel and other websites and heavily promoted through online fishing websites and search engines. Roughly half the \$100,000 is slated for production of videos and related materials, with the other half to be investing in advertising the videos online. The County's assistance will assure the Council meets the matching goal.

Path through History (\$10,000)

A statewide program to promote New York history to tourists is being developed under the title "Path through History." The North Country Region will receive a \$100,000 grant to implement various related projects such as photos shoots of historic sites, media familiarization tours, region-wide brochures, etc. As part of the process, the State has expressed the hope that these funds will be leveraged with local monies. The \$10,000 proposed for this purpose will allow the Council to underwrite projects that promote Jefferson County historic sites and events.

Wine Trail Fall Promotion (\$25,000)

With the recent growth of agri-tourism in general and the Wine Trail specifically, an opportunity exists to feature the County's wineries (and other harvest season attractions) at the core of a fall season marketing effort. The goal is to extend the tourism season and boost sales for many hospitality businesses by advertising the County as a wine and agricultural tourism destination focusing on September and October.

Watertown Airport Marketing Notes: Ideas and Costs for 2013 Projects

The following is an outline of suggested Watertown Airport marketing investments. The suggestions are made with a few assumptions:

- Prime target is Eastern Ontario
- o Target market includes both business and leisure air travelers
- Goal is to maintain a campaign over at least six months (as opposed to a short burst of more intense activity)
- Goal is to build long-term awareness of ART as an alternative airport choice that is included in travelers' search of trip-planning options
- Total available budget for 2013 is \$50,000

With these goals in mind, the options do not include TV or commercial radio, which would function better for a short-term campaign. While these purchases target Eastern Ontario, many also build awareness in Northern New York.

Below is a summary of estimated cost ranges. Each project has also been given a priority rank indicating a judgment on the priority of that particular option.
