**QUESTION:** Shall the City of Ponderay, Bonner County, Idaho adopt an ordinance providing for the imposition and collection of a 1.0% consumption tax on all of sales subject to taxation under chapter 36, title 63, Idaho Code with the exception of hotels/motels and any sales receipts that exceed \$999.99 in aggregate; for a period of Five(5) years from its effective date.

**The anticipated revenue for the 1.0% sales tax will be used on the following projects:**

- a.) **Lake Access - Safe Public access to Lake Pend Oreille and the Pend d Oreille Bay Trail including a railroad under crossing of the BNSF railroad tracks between the city and Lake Pend Oreille.**
- b.) **Field of Dreams - Development of a park, and regional recreation facilities at the Field of Dreams property.**
- c.) **Property and infrastructure associated with the development of said projects.**
- d.) **Administrative Costs.** (The city will retain the actual cost of collecting and administering the tax.)
