# MINUTES FOR THE BONNER COUNTY BOARD OF COMMISSIONERS' MEETING

October 4, 2016 – 9:00 A.M. Bonner County Administration Building 1500 Hwy 2, Suite 338, Sandpoint, ID

On Tuesday, October 4, 2016 the Bonner County Commissioners met for their regularly scheduled meeting with all three Commissioners present. Chairman Bailey called the meeting to order at 9:00 a.m. Pastor Barry Johnson of the New Song Bible Church led Invocation and the Pledge of Allegiance followed.

### ADOPT ORDER OF THE AGENDA

Commissioner Sudick made a motion to amend the order of the agenda:

Commissioner Bailey stepped down from the Chair and seconded the motion. All in favor. The motion passed.

Commissioner Bailey stepped down from the Chair and seconded the motion. All in favor, The motion passed.

 Discussion/Decision Regarding Appointment of a New Member to the Board of Community Guardian; Resolution

Commissioner Sudick made a motion to approve Resolution 16-70 for the appointment of D. Scott Bauer to the Bonner County Board of Community Guardian. Commissioner Bailey stepped down from the Chair to second the motion. All in favor. The motion passed.

1) Discussion/Decision Regarding Employee Paysheets

Commissioner Sudick made a motion to approve the Paysheets as presented: Sheriff's Office: 1 Full Time Employee; New Hire Patrol; Filling vacated position; BCEMS: 1 Part Time Employee; New Hire EMT; Filling Vacated Position; Bonner County Airports: 1 Part Time Employee; New Hire Maintenance Tech; New Position 2016/17 Budget. Commissioner Bailey stepped down from the Chair and seconded the motion. All in favor. The motion passed.

- 2) Discussion/Decision Regarding Policy Change to At Will Employment for Employed Personnel Commissioner Sudick made a motion to approve adopting the revised Bonner County Personnel Policy Manual to include a policy change from "For Cause" to "At Will" employment for all Bonner County exempt and non-exempt employees. Commissioner Bailey stepped down from the Chair and seconded the motion. All in favor. The motion passed.
- 3) Discussion/Decision Regarding Destruction of Records; **Resolution**Commissioner Sudick made a motion to approve Resolution 16-71 allowing HR/ Risk Management to destroy the above described files, following Title 74, Chapter 1 Public Records Act rules. Commissioner Bailey stepped down from the Chair and seconded the motion. All in favor. The motion passed.

### AIRPORTS - Jim Kaiser

- 1) Discussion/Decision Regarding Sandpoint Airport Leased Lot #8
  Commissioner Sudick made a motion to allow Mr. Wade Burnett to encumber the lease agreement for Lot 8 at Sandpoint Airport via a mortgage with Allen M. Mangum and Natalya V. Mangum. I further move to authorize the Chairman to sign the contract administratively. Commissioner Bailey stepped down from the Chair to second the motion. All in favor. The motion passed.
- 2) Discussion/Decision Regarding Priest River Airport Advisory Board Proposal to Change Meetings from Monthly to Quarterly
  Commissioner Sudick made a motion to approve the Priest River Airport Advisory Board request to change the frequency and meeting time to Quarterly and 12:00 noon. I further move to authorize the Chairman to sign the contract administratively. Commissioner Bailey stepped down from the Chair and seconded the motion. All in favor. The motion. Passed.
- 3) Discussion/Decision Regarding Permission for Priest River Airport to Solicit Bids for the Construction of a Maintenance Shed: Up to \$55,000 Commissioner Sudick made a motion to grant permission for Priest River Airport to Solicit Bids for the Construction of a Maintenance Shed at Priest River Airport with total construction cost not to exceed \$55,000 per IC 67-2805 (2). I further move to authorize the Chairman to sign the Memorandum administratively. Commissioner Bailey stepped down from the Chair and seconded the motion. All in favor. The motion passed.

#### **JUSTICE SERVICES – Ron Stultz**

 Discussion/ Decision Regarding the Bonner County 2016-2018 Memorandum of Agreement to Support the Community Incentive Program, the Re-Entry Program, and/or the Mental Health Program

Commissioner Sudick made a motion to approve the Bonner County Memorandum of Agreement to support the Community Incentive Program (CIP); the Re-Entry Program (REP); and/or the Mental Health Program (MHP). This agreement provides state funding for the 2016-2017 and 2017-2018 fiscal years for approved treatment programs for juvenile offenders and has been approved by legal. The MOA begins on October 1, 2016 and ends on September 30, 2018.

#### EMS – Bob Bussey

 Discussion/Decision Regarding Northern Lights Right-of-Way Easement, Multi-Purpose Facility, Sagle

Commissioner Sudick made a motion to approve the Right-Of-Way Easement Contract with Northern Lights, Inc. for the new EMS building site located in Sagle, Idaho. Commissioner Bailey stepped down from the Chair and seconded the motion. All in favor. The motion passed.

### **PUBLIC DEFENDER – Janet Whitney**

- 1) Discussion/Decision Regarding Conflict Public Defender Contract, First Level Commissioner Sudick made a motion to offer the Conflict Public Defender First level Contract to Serra Woods at the hourly rate of \$70.00 for court time and \$65.00 for case review and preparation. For misdemeanor, child protection, and juvenile justice cases the authorized hourly rate is \$65.00 for court time and \$55.00 for case review and preparation. Commissioner Bailey stepped down from the Chair and seconded the motion. All in favor. The motion passed.
- 2) Discussion/Decision Regarding Conflict Public Defender Contract, Second Level Commissioner Sudick made a motion to offer the Conflict Public Defender Second Level Contract to Bruce H. Greene at the hourly rate of \$70.00 for court time and \$65.00 for case review and preparation. For misdemeanor, child protection, and juvenile justice and post-conviction cases the authorized hourly rate is \$65.00 for court time and \$55.00 for case review and preparation. Commissioner Bailey stepped down from the Chair and seconded the motion. All in favor. The motion passed.
- 3) Discussion/Decision Regarding Conflict Public Defender Contract, CASA Contract Commissioner Sudick made a motion to offer the contract for services of Court-Appointed Special Advocate to Margaret Williams in the amount of \$28,000. This contract is conditioned on acceptance in writing within seven days. Commissioner Bailey stepped down from the Chair and seconded the motion. All in favor. The motion passed.

### PLANNING - Milton Ollerton

1) Discussion/Decision Regarding Construction Proposal from Colin Construction for the Remodel of the Planning Departments Reception Area; \$24,965

Commissioner Sudick made a motion to approve the Colin Construction Inc. proposal to remodel the reception area in the Planning Department. Commissioner Bailey stepped down from the Chair and seconded the motion. All in favor. The motion passed.

#### **ROAD & BRIDGE - Don Hutson**

1) Discussion/Decision Regarding Eastriver Spur Easement #100114 (IDL); \$3900 Commissioner Sudick made a motion to approve Easement # 100114 as prepared by the Idaho Department of Lands for the adoption and maintenance of Eastriver Spur Rd, and to allow the board to sign the easement and for the Road and Bridge Department to move forward with planning for the replacement of the bridge and maintenance of the road. Commissioner Bailey stepped down from the Chair and seconded the motion. All in favor. The motion passed.
