Now, if the conditions stated above are violated, the sum of the bond shall be forfeited unto the State of Texas for the benefit of Hill County, Texas, and, in addition, I will pay all necessary and reasonable expenses and fees that are incurred by any peace officer in re-arresting me. However, if I fulfill all the terms of this bond, this obligation shall become void and the amount deposited herein shall be refunded to me, otherwise to remain in full force and effect.
