**AN ORDINANCE TO AMEND CHAPTER 70, UTILITIES, ARTICLE III,
ELECTRIC RULES AND REGULATIONS**

BE IT HEREBY RESOLVED by the Mayor and Council of the Town of Smyrna, a majority thereof concurring in Council duly met that Chapter 70, Utilities, be amended as follows:

Section 1. Amend Chapter 70 ("Utilities"), Section 70-172. Service classification GS, General Service, commercial nondemand and industrial, (d) monthly rate (1) Commercial as follows:

- (a) Customer charge - delete "\$6.50" and insert in lieu thereof (see fee schedule)
- (b) Energy charge - delete "0.135" and insert in lieu thereof (see fee schedule)
- (c) Electric heat/hot water - delete "0.10" and insert in lieu thereof "see fee schedule)
- (d) Minimum bill - delete "6.50" and insert in lieu thereof (see fee schedule)

Section 2. Amend Chapter 70 ("Utilities"), Section 70-172. Service classification GS, General Service, commercial nondemand and industrial, (d) monthly rate (2) Industrial customers (demand). as follows:

- (a) Customer Charge - delete "\$6.50" and insert in lieu thereof (see rate schedule)
- (b) Energy charge - delete "0.068" and insert in lieu thereof (see fee schedule)
- (c) Demand charge (all kw) - 1. Summer - delete "14.62" and insert in lieu thereof (see fee schedule); 2. Winter - delete "9.67" and insert in lieu thereof (see fee schedule)
- (d) Minimum bill - delete "6.50" and insert in lieu thereof (see fee schedule)
