## Hometown Neighbors as Heroes



Imagine being on-call 24 hours a day, seven days a week, 365 days a year. This is what a dedicated group of 41 of your friends and neighbors do as volunteers on the Lindsborg Emergency Medical Service and the Lindsborg Volunteer Fire Department. The dedication of these men and women goes beyond responding to emergency situations.

The EMS volunteers must take a 16 week training course and then pass a test administered by the Kansas Board of Emergency Medical Services to become certified to serve as emergency medical technicians. Volunteer firefighters receive Firefighter I and Firefighter II training as part

of their service to the department. But the training does not stop with the completion of these courses. Both departments meet monthly for continuing education training.

Training exercises have been planned and executed in collaboration with the Smoky Valley School District, Bethany College and Lindsborg Community Hospital. These exercises have included many different scenarios from mock accidents, fires, school shootings and terrorist attacks. These collaborative exercises have allowed the administrations of the respective institution to fine tune their

## Vehicular Accidents on the Rise

Early records show an increase in 2007 vehicle accidents. Although most of these incidents have been due to ice and snow packed roads, it still is an issue of concern. The most common excuse heard by police after an accident is, “I never saw him.” Virtually all accidents involve inattention by one or both drivers. Inattention can be caused by daydreaming, distractions (cell phones),

sleepiness, fatigue and talking. Most collisions occur within a short distance from home. We tend to let our guard down because we are familiar with the areas that we drive to on a regular basis. Conscientiously and continuously analyze your surroundings. Concentrate on what you are doing and what others are doing. For most of us, driving is the most dangerous thing that

we will ever do, and it deserves our full attention.

## Waterline Replacement Program Results in Lower ISO Rating

After years of installing water mains in new subdivisions, a decision was made to rebuild the City's Waterline Infrastructure. The desired outcome was to have a grid work of interconnected water mains that would improve service to the community, reduce the possibility of low-flow stagnant water, and increase what is known as fire-flow. Fire-flow is the amount of water that can be made available to fire hydrants in the event of a fire. The City did have an existing grid work of lines, but many of the lines were old and only 4 inches in diameter. Mineral buildup in

the lines reduced the flow even further. In previous years, outside contractors were hired to do major line replacements. Although a large amount of lines were replaced at one time, cost of such projects were extremely high and funding was a challenge. It is within the City's annual budget to replace two to four block segments per year.

From the start of the program in 2000, the Water Department with assistance from Streets and Wastewater has completed seven projects of line replacements for a total of

17 blocks. Improved service and fire-flow has been achieved. The added and unanticipated benefit is the reduction of the City's ISO rating. The City's current rating is a 4. The Property and Casualty Insurance Industry calculates premiums for residential, commercial and industrial properties. Lower ratings equal lower premiums.


## Be Prepared and Informed

“Tornado Season” is just around the corner. Siren testing begins in March on the 1<sup>st</sup> and 3<sup>rd</sup> Wednesday of each month (weather permitting) at 11:00 a.m. Do not rely solely on the siren. You may not be able to hear it while indoors. Tune in to local radio and television channels for up-to-date severe weather information. If Lindsborg is in a “tornado warning” or the siren activates, remain indoors and move directly

to the basement or the smallest room near the center of the house. Your safety is our number one concern. Have a good Spring and be prepared!




## Tired of Writing Checks or Getting Late Fees?

City bills can be paid conveniently and automatically by bank draft from a checking or a savings account. Setting up a bank draft is an easy process. Stop by or call City Hall (785) 227-3355, to receive a form. Simply fill it out and attach a voided check or deposit slip (for account and routing number verifi-

cation). After one additional utility billing cycle, your City bill will be drafted automatically from your account until you notify us that you no longer wish to participate. Accounts are drafted on the 10<sup>th</sup> of each month or there about depending on banks being opened for business. No late fees are incurred.

The billing information you receive in the mail will reflect the date and the exact amount that will be drafted from your account.

## Election Q & A

**(Q) Do I have to register before every election?**

**(A) NO** - Once registered, you remain registered *unless*: you move, your name changes or you do not vote in two (2) state general elections. The Monday, two (2) weeks before every election, voter registration closes at 5:00 pm.

**(Q) Where do I register?**

**(A) City Clerks Office at City Hall** 101 S. Main

You must be a United States citizen and 18 years of age or older on the date of the election.

**(Q) When and how do I vote?**

**(A) Advance vote** three (3) weeks prior to every election. You do not have to be absent from the county on Election Day to Advance Vote. You may Advance Vote in Person at the County Clerk’s office (117 N. Maple) between the hours of 8:00 & 5:00 p.m. weekdays. In-person advance voting ends at **noon** the day before

the election.
