Shall the City and Borough of Sitka pay its remaining General Obligation Bonds authorized by the voters in 1996 for Baranof Elementary and Sitka High School improvements through the 1% additional seasonal sales tax collected from April 1 to September 30 instead of from the General Fund, estimated to be approximately \$380,000/year?

Informational note: Approval of this ballot proposition would continue the 1% seasonable sales tax for an additional two years. Additional seasonal sales tax surplus exists to pay for the General Obligation Bonds. General fund monies not required to pay these General Obligation Bonds could be used for other general/government and educational needs and/or could reduce the need to reduce governmental services.
