(INSTRUCTIONS: If you want to vote to authorize the Council of the City of Sitka, Alaska, to issue bonds as stated in the proposition below, place an "X" in the square following the word "YES." If you want to vote against such authorization, place an "X" in the square after the word "NO.")

INSTRUCTIONAL NOTE: The following proposition is intended to amend the existing authorization as approved under Bond Proposition No. 2 at the General Election of October 7, 1969, and more fully stated in Ordinance No. 433. If approved this proposition will supercede the previous authorization. The changes from the original bond proposition are: (1) The principal amount of the bonds has been increased from \$220,000 to \$260,000, and (2) The words "on land already owned by the City" have been deleted and the words "to be located on the southerly portion of Lot 1, Block 2 of the Swan Creek Subdivision to the City of Sitka, Alaska, the costs to include any necessary improvements to the proposed site" have been inserted. If the amended proposition as follows fails, the proposition as approved October 7, 1969, will remain valid.

BOND PROPOSITION

Shall Bond Proposition No. 2 as approved at the General Election of October 7, 1969, be amended to read as follows:

Shall the City of Sitka, Alaska, as more specifically provided in Ordinance Nos. 433 and 437 be authorized to issue its General Obligation Bonds in the principal amount of not to exceed \$260,000 and bearing interest at a rate not to exceed 9% per annum, to mature in such amounts and at such times as determined by the Council but not later than 30 years from date of issue and to be payable both principal and interest from annual levies of taxes to be made upon all taxable property within the City without limitation as to rate or amount, for the purpose of providing funds to pay the cost of construction, acquisition and equipping a new fire hall to be located on the southerly portion of lot 1, Block 2, of the Swan Creek Subdivision to the City of Sitka, Alaska, the costs to include any necessary improvements to the proposed site, all as shown on the plan thereof in the office of the City Director of Public Works.
