

One absentee ballot for the Special Election of November 12 was opened with a yes vote on each of the three propositions being tabulated. The Clerk presented Certificates of the Judges and Clerk of Election held November 12, 1957, together with the ballots cast at said election, the ballots spoiled, unused ballots, registration book, duplicate registers kept by the Clerk, containing the record of the Election, including the names of all persons who voted thereat, and all other material returned to her by the Judges and Clerks of Election. The council canvassed the ballots and the results of the election and found the Certificates of the Judges and Clerks to be accurate and complete. A motion was made by Councilman Shennett seconded by Councilman Knight that the reports of the Judges and Clerks contained in their Certificates be accepted, approved and found correct; and that the Council find 125 persons voted in favor of Proposition I submitted to the voters at said election, that 129 persons voted against said proposition and that 0 ballots were spoiled; the proposition failing since less than 65% of the votes cast were in favor of said proposition; that 170 persons voted in favor of Proposition II submitted to the voters at said election, that 83 voted against said proposition, that 0 ballots were spoiled, the proposition carrying since more than 65% of the votes cast were in favor of said proposition; that 156 persons voted in favor of Proposition III submitted to the voters at said election, that 95 persons voted against said proposition, that 0 ballots were spoiled, the proposition failing since less than 65% of the votes cast were in favor of said proposition. Said motion was then put to a vote and carried unanimously.

### Proposition I

Shall the City of Sitka, as more specifically provided in Ordinance No. 194 of said City, be authorized to issue its general obligation bonds in the amount of not to exceed \$150,000 said bonds to bear interest at a rate of not to exceed six percent per annum, to mature serially in not to exceed 30 years from date of issue and to be payable, both principal and interest, from City of Sitka tax revenues for the purpose of purchasing or constructing and equipping a municipal building, and for all expenses incidental thereto including acquisition of lands not now owned by the City, if necessary.

### Proposition II

Shall the City of Sitka, as more specifically provided in Ordinance No. 194 of said City, be authorized to issue its general obligation bonds in the amount of not to exceed \$115,000, said bonds to bear interest at a rate of not to exceed six percent per annum, to mature serially in not to exceed 30 years from date of issue and to be payable, both principal and interest, from City of Sitka tax revenues for the purpose of improving, paying, widening and reworking (along with such sewer construction as is advisable prior to paving) the southerly portion of Baranof Street, the westerly portion of Lincoln Street, that portion of Front Street between Sitka Cold Storage Co. and Lincoln Street, that portion of the Military Road from the Indian Village to intersection with Halibut Point Road and paying all expenses incidental thereto.

### Proposition III

Shall the City of Sitka, as more specifically provided in Ordinance No. 194 of said City, be authorized to issue its general obligation bonds in the principal amount of not to exceed \$35,000 said bonds to bear interest at a rate of not to exceed six percent per annum to mature serially in not to exceed 30 years from date of issue and to be payable, both principal and interest, from City of Sitka tax revenues for the purposes of purchasing and installing a general fire alarm system including a coded siren, and paying all expenses incidental thereto.
