The City of Petaluma is writing in support of the Sonoma County Water Agency's *Southern Sonoma County Storm Water Resource Planning Project* to develop a Storm Water Resource Plan for the Petaluma River Watershed and Petaluma Valley Basin.

The City of Petaluma will act as a collaborating entity with the Water Agency on the Southern Sonoma County Storm Water Resource Planning Project. The City of Petaluma has a Surface Water Operation and Maintenance Plan, is a regulated MS4 Stormwater Permittee in the Petaluma River Watershed, and has an adopted Floodplain Management Plan. The City of Petaluma's surface water management is achieved through a network of natural creeks, mechanized channels; storm drains and three storm water pump stations that flow to the Petaluma River. During storm events, precipitation and water levels in major creeks are monitored using a computerized system of stream gauges and precipitation instruments (Flood ALERT system.) The compliant Storm Water Resource Plan will help the City identify and prioritize projects for storm water and dry weather runoff that will provide multiple benefits through water quality improvement, beneficial reuse, habitat enhancement and flood reduction purposes.

The City of Petaluma will contribute \$10,000 in cash and in-kind services equal to \$20,000 to support the proposal for a total match amount of \$30,000. The in-kind services provided by the City in the past year have included identifying potential citywide storm water projects, developing preliminary estimates for citywide storm water projects, and developing a citywide creek and stream maintenance plan.

The City of Sonoma will act as a collaborating entity with the Water Agency on this planning project. The City of Sonoma is a regulated MS4 Stormwater Permittee in the Sonoma Creek Watershed. As an MS4 Permittee, the City takes actions to reduce pollutants in stormwater runoff from urbanized areas in its jurisdiction, including regulating development to reduce the quantity of stormwater runoff, as well as supporting water quality monitoring efforts. The City of Sonoma is also a contributor of plan materials, especially the City of Sonoma Storm Drain Management Plan, which includes flood modelling data and prioritized flood mitigation projects.




