1. Call to Order.

Mayor Dugatto called the meeting to order at 7:00 PM.

2. Pledge of Allegiance.

Mayor Dugatto led the Pledge of Allegiance.

A moment of silence was held for the recent tragedies within the valley communities.

3. Roll Call.

Mayor Dugatto requested roll call. Present were Ms. DeGennaro, Mr. Iacuone, Ms. Monaco, Mr. Gerckens, Mr. Sill, Mr. DiMartino, Mr. Anroman, Mr. DiCenso, and Mr. Olenoski.

4. Additions, Deletions, Corrections and Adoption of Agenda

Mr. Gerckens motioned to make the following changes:

- Correct Item 9.9 Parking Authority should read "Parking Garage"
- Delete Item 11.1
- Add Item 11.1 Treasurer's Report to discuss Bond Upgrade
- Correct Item 11.4 to read

"249 Hawthorne Avenue. Move to accept the sum of \$27,250 as a full payment of the blight lien relative to 249 Hawthorne Avenue, provided the blight conditions are remedied on or about October 31, 2015. If said blight conditions are not remedied by said date, the full amount of the blight lien shall be due and payable and continued to accrue on a daily basis."

• Correct Item 11.5 to read

"Agreement for installation of Non-Standard Illuminations Appurtenances. Move to approve the agreement by and between the City of Derby and the State of CT relative to the Route 34 over the Naugatuck River Agreement for Installation of Non-Standard Illumination Appurtenances on Bridge No. 00947 and further authorize Mayor Anita Dugatto to sign any and all documents necessary to effectuate same."

Add Item 11.9

Adopt resolution authorizing the Deputy Director of the Community Development Office for the City of Derby to sign any and all documents in order to apply for a \$200,000 maintenance improvement grant for the Derby Public Library through the FY2015-2016 State Public Library Construction Grant.

Mr. DiMartino seconded and the motion carried.

5. Public Portion

Jacqueline Quiroz of 8 Monaco Circle – Spoke regarding the Gilbert Street parking permit issue. She asked if it was mandatory for everyone to buy the permit. Ms. DeGennaro stated that it was not mandatory.

Ed Dicamillo (on behalf of his mother Theresa who owns 29, 31, and 33 Gilbert Street) – Spoke about the Gilbert Street parking permit ordinance as well.

The Board stated that they will reopen the public portion during the discussion of the Gilbert Street ordinance.

Fredrick Picroski – spoke about the fire on Derby Avenue. He hopes the media reporting was incorrect. He saw the fire then heard the car accident. At that time he went back to his home and called 911 to report the fire as well as the accident. The newspaper stated that the police noticed the fire upon responding to the reported car accident. He is also asking for the building to come down because the stench is horrible. His wife is ill and he will not tolerate the unbreathable air.

6. Approval of Minutes

6.1. Regular meeting - June 25, 2015

Mr. Iacuone motioned to table the minutes because even though Mr. Gerckens and Mr. Sill made the motions, they are not listed in the roll call. He also asked that the documentation that was submitted to the Board by the WPCA be attached to the minutes. *City Clerk will be contacted for said documentation. Mr. Anroman seconded and the motion carried.

6.2. Regular meeting - July 23, 2015

Mr. Gerckens asked that the word "date" after "later" be added to item 8.2.4.

Ms. DeGennaro motioned to amend Mr. Gerckens motion and make the following corrections:

- Item 8.2.9 should say "waived the fee with the exception of the payment of the security deposit".
 - *Upon listening to the recording it was determined that Ms. DeGennaro's requested amendment was not added due to the fact that it was stated that they had already payed the security deposit.
- Item 9.5 "addressed" should state "addresses"
- Item 12.1 should read "update" not "updated"
- Item 13.2 add the word "number" after each word "list"

Mr. Iacuone asked that the sentence under Item 6.3 be separated into two sentences.

The current sentence states that "A resolution and absentee votes need to be added to the minutes." The minutes will be changed to state "A resolution needs to be added to the minutes. The absentee votes need to be added to the minutes."

Mr. Iacuone also requested that the correspondence from the absentee voters be added to the minutes.

Mr. Gerckens accepted the changes. Mr. Sill seconded and the motion carried.

Ms. Monaco abstained.

7. Administrative and Appointments

7.1 Refund of excess taxes paid through August 18, 2015 in the amount of \$247.03 as recommended by Denise Cesaroni, CCMC, Tax Collector

Mr. Sill motioned to approve the refund of the excess taxes in the amount of \$247.03. Mr. Anroman seconded and the motion carried.

8.3. Operations & Procedures

8.3.1. Request for salary increase from Registrar of Voters to \$9,500 per year per registrar effective July 1, 2015 based upon newly instituted mandatory certification by the State of Connecticut. Discussion and possible action.

Ms. DeGennaro stated that the current salary is \$7,250 and the State of CT is requiring extensive certification. Ms. DeGennaro motioned to increase the salary to \$9,500 as requested. Mr. DiMartino seconded and the motion carried.

8.3.2. Proposed new ordinance, City of Derby Code, Chapter 186 Vehicles and Traffic Article X §186-58 et. Seq. entitled Gilbert Street Residential Parking Lot" for use of city owned 40-42 Gilbert Street as off street parking lot. Discussion and possible action.

The Board and Commissioner DeFala discussed the ordinance at length.

Ms. DeGennaro motioned to "enact new ordinance as address with the correction that item 186-60 should say issuance instead of insurance, under that section the correction to read a permit shall be issued upon application only to those who are residents or proprietors as defined herein as well as one last correction under 186-62 Use of Permits Item G the last sentence I would proposed that it be corrected to read the display of a parking permit not entitled to such parking permit shall constitute such a representation of this section." Mr. DiCenso seconded and the motion carried.

8.3.3. Proposed new ordinance, City of Derby Code, Chapter 21, Fire Department, §21-27 entitled "Fire Department Safety Officer" for position created within the Derby Fire Department. Discussion and possible action.

Ms. DeGennaro motioned to adopt the new ordinance with the following three corrections: Item 21.17, grammatical corrections, subsection B five years "experience"; section C two periods one should be deleted; item D should say "investigate all line \underline{of} duty". Mr. DiMartino seconded and the motion carried.

Several members of the audience stated they would offer donations.

Mr. Gerckens and Mr. Olenoski approved to amend the motion change to state that the Fitness Center be named after Michael J. Regan. The motion carried.

Mr. Gerckens added that the Derby Hall of Fame Committee did a great job.

Motioned by Mr. Gerckens, Mr. Sill seconded and the motion carried.

11.9. Adopt resolution authorizing the Deputy Director of the Community Development Office for the City of Derby to sign any and all documents in order to apply for a \$200,000 maintenance improvement grant for

the Derby Public Library through the FY2015-2016 State Public Library Construction Grant.
