REVIEW 2015 ROAD BOND PROJECT - PHASE 1

Mr. DeFala reviewed the four roads that make up Phase 1:

Evelyn Road

Road length and width – 458 ft. x 53 ft. Total Square Footage – 24,274 ft.² Curb – None 4 manhole tops, 2 catch basin tops

Yocher Lane

Road length and width – 399 ft. x 16 ft.

Total Square Footage – 6,384 ft.²

Curb – None

1 manhole top, 1 double and 1 flat catch basin top

Benanto Drive

Road length and width – 914 ft. x 32 ft. Curb – 1,828 linear ft. Total Square Footage – 29,248 ft.² 3 manhole tops, no catch basin tops

Pleasant View Road

Road length and width – 2,170 ft. x 30 ft. Total Square Footage – 65,100 ft.² Curb – 4,340 linear ft. 8 manhole tops, 18 catch basin tops

Ms. Finn reviewed the Invitation to Bid timeline for those present.

- Pre-bid construction meeting on Wednesday, March 18, 2015 at 9:30 a.m. in the Joan Williamson Aldermanic Chambers for prospective contractors.
- Bids will be received until 11:00 a.m. on Tuesday, March 24, 2015 at which time they will be publicly open and read aloud in the Joan Williamson Aldermanic Chambers.

Mr. McLiverty informed the committee that he would be meeting with Mr. DeFala and Ms. Finn to set up the financials for the project. Once this is underway a financial report will accompany the meeting agenda each month. Ms. Finn noted that there is language in the Contract Documents that states all invoices for payments must be presented by the first Friday of the month in order for the Road Bond Committee to approve and move the invoices to the Board of Aldermen for their meeting on the fourth Thursday of the month.

Mr. DeFala said the W.P.C.A. would like to be included on the agenda for next month's meeting. They would like to discuss storm water drainage on Emmett Avenue. They want to do a brief presentation. Mr. Gerckens suggested that they submit a bullet point outline of what they would like to discuss in lieu of an oral presentation.
