### **2. Roll Call**

Present were Commissioners DeGennaro, Mastrianni, and Bottone. Also present were Chief Narowski and Deputy Chief Todd.

### **3. Public Portion**

Stephan Jonas – 660 Hawthorne Avenue. Requested help regarding the speed of vehicles on Hawthorne Avenue. On April 6<sup>th</sup> he submitted a letter regarding the installation of stop signs at Patty Ann Terrace and Hawthorne. Commissioner Bottone asked about the recent bridge construction. She wanted to know if they could do the work at night. DC Todd stated that the bridge is owned by the State and the city has no control over when the work is conducted. He also stated that the department attended pre-construction meetings and voiced the traffic concerns which were taken into consideration.
