A meeting of the Derby Board of Police Commissioners was held on 06 OCT 14 at City Hall, 1 Elizabeth Street, Derby.

The meeting was called to order at 6:00 P.M. by Commissioner DeGennaro.

### 1. Pledge of Allegiance

### 2. Roll Call

Present were Commissioners DeGennaro, Bottone, and Mastrianni. Also present was Chief Narowski.

### 3. Public Portion

No one from the public was in attendance.

### 4. Deletion, correction, adoption of agenda

Commissioner DeGennaro motioned to accept the agenda as is and Commissioner Mastrianni seconded. The motion carried without further discussion.

### 5. Acceptance of Previous Meeting's Minutes

Commissioner DeGennaro motioned to accept the 08 SEP 14 minutes and Commissioner Bottone seconded. The motion carried without further discussion.

### 6. Old Business

Chief Narowski discussed the overtime breakdown report. He also stated that 452 infractions were issued during the Distracted Driving High Visibility Enforcement program. Chief Narowski advised the Board that the new down tilt radio antenna did not resolve the issues and they are going to be conducting a more extensive in house study.

### 7. New Business

Chief Narowski discussed the traffic stops report released by the State and that the department is looking into body worn camera options. He also stated that he will be attending a conference regarding excited delirium and in custody deaths.

### 8. Department Reports

Chief Narowski updated the commissioners on the department's patrol activity. He also reviewed the status of the police department's budget, crime statistics, and capital projects.

11. Executive Session

A motion to go into executive session and have Chief Narowski present for personnel updates; and Chief Narowski, Union President Netto, and Officer Donofrio present for discussion and possible action regarding grievance 14-02 was made by Commissioner DeGennaro, seconded by Commissioner Bottone, and carried unanimously.

Commissioner DeGennaro motioned to table grievance 14-02 and hold a special meeting at a later date to take action. Commissioner Bottone seconded and the motion carried.
