Office Report

Finance Department Director Tom Thompson had asked to have an increase of \$30,000.00 in the budget for Worker's Compensation. Marcy is learning how to do payroll for WPCA she is training on Mondays. WPCA is going to take a look into Pilot and the housing authority regarding billing.

Superintendent Report

Fixed pipe on 34 that had issue. A theory is that 10 years ago when the City put a new sewer line in one of the joints didn't have a gasket in the belt and is causing an issue with the pipe. Will look into this further when more information is provided. Pump Station is complete just need to clean up around area and need to finish the hook up for generator. Safety caught off on pumps will automatically shut down. One pump had issue there are two working the third (the backup) is being fixed then returning to plant.

Engineers Report

WPCA had asked Anthony to look into the situation with Minerva St. and the property owner regarding regulations. He is re doing the property they are in contact with the property owner. Received a letter from Regional Water Authority regarding the sub metering. There was a misunderstanding, they understand what they are doing and are okay with what WPCA is doing with putting in a separate meter. Marcy and Anthony DeSimone will look into the regulations on adding a separate meter to modify. One modification being change in units where he is being billed for 6 units but only has 4 units, so just clarifying the process for a situation like that for any future billing issues. House Building Inspector Program getting set to get started regarding going into people's houses in one section of the City the state is paying for to see if homeowners have sub pumps etc. This will begin on June 2nd and will be posted on website as well, homeowners will be contacted beforehand. John Saccu had seen the rough draft of the letter that will be open to the public and would like it to be re worded in some areas before finalizing.
