8429. Hudsonville Community Fair Banners.

Motion by Brandsen, seconded by Raterink, to authorize the Mayor and City Clerk to sign the attached Memorandum of Understanding between the City of Hudsonville and the Hudsonville Community Fair regarding the installation and removal of Community Fair promotional banners on City-owned light poles.

City Manager Waterman reported that the Fair Board is requesting some minor changes to the Memorandum of Understanding. The fair board would like the banners put up three weeks in advance of the fair, and they would like to receive an estimate from the City of the cost to install the banners before the banners are put up.

Motion by Leerar, seconded by Brandsen, to table the motion to approve the Memorandum of Understanding with the Fair until the Fair Board has acted on or approved the Memorandum of Understanding.
