8857. Redevelopment Ready Communities
Karen Wieber, Redevelopment Ready Communities Planner with the Michigan Economic Development Corporation (MEDC), was present and reviewed with the City Commission the Redevelopment Ready Communities (RRC) background, the findings from the RRC Report and the next steps for the city to take to be RRC Certified.
