Petition Summary: This request is to rezone 16.42 acres from A-1 Ag to C-1 Conservancy including trails for public use.

Comments/Recommendations

- 1) The application proposes creating a lot that will be available to the public for open space recreation, including hiking trails. The C-1 district would prohibit any structures requiring a zoning permit.
- 2) The associated certified survey map has been submitted for formal review.
- 3) The proposal is consistent with the adopted comprehensive plans by meeting the policies of the Town of Arena's Section E & H.

Town Recommendation: The Town of Arena recommends approval of both the zoning change and CUP for public trails.
