

RESOLUTION NO. 1-0599

**RESOLUTION AUTHORIZING CREATION OF AN ADDITIONAL
DEPARTMENT OF SOCIAL SERVICES SUPERVISOR
FOR IOWA COUNTY**

WHEREAS, the Iowa County Department of Social Services has assumed the Juvenile Intake Services and has added a foster care coordinator;

WHEREAS, the Iowa County Department of Social Services has a unit staff of 12 persons under the supervision of only one social services supervisor;

WHEREAS, on February 9, 1999 the Department of Social Services Board approved a motion to create an additional Department of Social Services Supervisor for Iowa County to undertake recruitment efforts to fill the position;

WHEREAS, the Committee on Salary & Personnel acknowledges the need for additional Iowa County Department of Social Services supervisory staff and formally by motion on March 4, 1999 indicated their support for the Department of Social Services Board recommendation regarding the same;

NOW, THEREFORE, BE IT RESOLVED BY THE IOWA COUNTY BOARD OF SUPERVISORS that it does hereby create an additional Department of Social Services Supervisor for Iowa County.

BE IT FURTHER RESOLVED, that the minimum qualifications for the created position shall be a Masters Degree in Social Worker or related field and work experience in a County Social/Human Services Department.

BE IT FURTHER RESOLVED that upon the joint recommendation of the Social Services Board and the Committee on Salary & Personnel the created position shall have a starting salary range of \$35,000.00 and \$36,000.00 with a probationary increase at the end of one year of \$1,000.00.
