

Resolution NO. 2-0204

To The Honorable Iowa County Board of Supervisors:

WHEREAS, the Iowa County Land Records Modernization Plan, as approved by the Wisconsin Land Information Board, has remonumentation and parcel mapping as stated goals to be completed as soon as possible;

WHEREAS, the eligibility for grant monies is contingent upon the Modernization Plan being followed;

WHEREAS, the Office of Planning and Development-Land Records Department creates parcel maps digitally for use in the County's Geographic Information System;

WHEREAS, it is recognized that section corner coordinates are vital for accuracy in parcel mapping;

WHEREAS, recorded tie sheets and digital orthophotography are now available to assist in parcel mapping;

WHEREAS, Iowa County has significant investment already made in parcel mapping, which is currently within 6 months of current date;

WHEREAS, a resolution currently exists, Number 5-198, which directs the Iowa County Surveyor, as part of his/her duties, to apply coordinates to corners with recorded tie sheets;

WHEREAS, allowing all surveyors to submit coordinates; would allow the mapping to increase accuracy in parcel mapping sooner;

NOW, THEREFORE, BE IT RESOLVED BY THE IOWA COUNTY BOARD OF SUPERVISORS, to adopt this resolution which allows any surveyor to submit coordinates for tie sheets recorded prior to January 20, 1998 at a reimbursement rate of \$50.00 for each corner. This resolution shall remain in effect until August 31, 2004 or until the total expenditures under this resolution reach \$10,000, whichever comes first.

BE IT FURTHER RESOLVED that submittals under this resolution shall be subject to the conditions listed on Attachment A.

Attachment A

In accordance with Resolution Number _____, any surveyor is entitled to \$50.00 reimbursement for each section corner coordinate provided to the County providing all the following apply:

- A. Coordinates must be provided for only those section corners which had a tie sheet recorded at the Register of Deeds Office prior to January 20, 1998. (Contact Office of Planning and Development for listing of ties sheets on record as of January 20, 1998)
- B. Coordinates shall be reimbursed on a first come – first serve basis. Any coordinates submitted in which we already have coordinates for, shall not be reimbursed. (Contact Office of Planning and Development for current listing)
- C. Coordinates shall include the northing and the easting coordinate and rounded to nearest 100th decimal place. (ex. 352374.93, 126871.03)
- D. Section corner coordinates are received prior to August 31, 2004 and the total reimbursements for these \$50.00 reimbursements do not exceed \$10,000 for the duration of the Resolution.
- E. All coordinates shall be subject to final approval from the Office of Planning and Development. The Iowa County Office of Planning and Development reserves the right to deny payment or request validation of any coordinate. Coordinates may be denied for the following reasons:
 1. The Office of Planning and Development already has the corner coordinate on file.
 2. The corner does not appear to be located in the correct location.
 3. Coordinate is received after Resolution ending date or the \$10,000 expenditure cap has been met.
