- 1. The Board of Aldermen find that all requirements of law have been met in the passing of this Ordinance:
- 2. The Board of Aldermen hereby establish new traffic fines and court costs as set out in Exhibit "A" which is hereby incorporated for all practical purposes;
- 3. This Ordinance shall take effect and shall be in full force and effect from the date of its passage.

Should any word, phrase, sentence, paragraph or portion be found illegal, invalid, void or unconstitutional, the remaining portions are hereby severed and shall remain in full force and effect.

This Ordinance shall become effective on date of passing.
