ORDINANCE 2006-09

AN ORDINANCE AMENDING ORDINANCE 2005-004 (REGULATING OIL AND GAS OPERATIONS WITHIN THE CITY LIMITS OF PENITAS), TO PROHIBIT OIL AND GAS DRILLING ON 29.161 ACRES OF LAND LOCATED IN LOT 1, LOT 2, LOT 3, LOT 4, LOT 5, AND LOT 6, BLOCK 1, OF "MAP OF SUB. "D" HOMEVILLE ASSN. OF POR. 76 HILDAGO CO."

WHEREAS, the City of Peñitas is a General Law City operating under the General Laws of the State of Texas;

WHEREAS, the City of Peñitas adopted Ordinance 2005-004 adopting certain regulations related to oil and gas operations within the City Limits of Peñitas and providing for a severability clause.

WHEREAS, the City of Peñitas desires to amend Ordinance 2005-004 in order to prohibit oil and gas drilling on a certain tract or parcel containing 29.161 acres of land in Lot 1, Lot 2, Lot 3, Lot 4, Lot 5, and Lot 6, Block 1, of "Map of Sub. "D" Homeville Assn. of POR. 76 Hildago Co.," a Subdivision of Record in Volume 6, Page 36, of the Hildago County Map Records.

THEREFORE, be it Resolved And Ordained by The Board of Aldermen of the City of Peñitas, to wit: as follows


1. The Board of Alderman find that all requirements of law have been met in the passing of this ordinance;
2. Ordinance 2005-004, of the City of Peñitas, is hereby amended to prohibit drilling for oil and gas on all that certain tract or parcel containing 29.161 acres of land in Lot 1, Lot 2, Lot 3, Lot 4, Lot 5, and Lot 6, Block 1, of "Map of Sub. "D" Homeville Assn. of POR. 76 Hildago Co.," a Subdivision of Record in Volume 6, Page 36, of the Hildago County Map Records.

Shall any phrase, word, sentence, paragraph or portion of this Ordinance be found void or voidable or unconstitutional the remaining portion shall remain in full force and effect.

PASSED on this the 13<sup>th</sup> Day of September 2006, at a regular and duly called meeting of the Board of Aldermen of the City of Peñitas at which a quorum was present.




