northwesterly and in a straight line and along the center of Chestnut street to a point in center of the Las Animas river; thence westwardly and along the center of said Las Animas river to the northwesterly corner of ward one, as established in the preceding section; thence southwardly and along the centers of Animas, Church to Beech street and Garfield avenue to place of beginning.

Third Ward—Commencing at a point on the center of the right-of-way of the Pueblo and Arkansas Valley Railway where the northerly boundary line of ward one, as established in section one of this ordinance, is intersected by the circular line to the point where the same intersects the south line of Cone's Addition; thence westward and along the south line of the said Cone's Addition to the southwest corner of said addition; thence northward and along the west line of Cone's and Terry's Additions, and Grass & Allen's Addition to the northwest corner of Grass & Allen's Addition; thence eastwardly, southwardly and eastwardly and along the northerly line of Grass & Allen's Addition to the center of State street; thence southward and along the center of State street to the point of intersection of State with Kansas avenue; thence and along the center of Kansas avenue to its intersection with Nevada avenue; thence southward and along the center of Nevada avenue to the center of the Rio Las Animas; thence westwardly and along the northerly line of ward one, as by this ordinance established, to the place of beginning.

Fourth Ward—Bounded on the north and east by the line of the original city limits; on the south by the Rio Las Animas and on the west by the easterly line of ward three, as by this ordinance established.

Fifth Ward—Contains all that territory within the limits of said city and lying south of the Rio Las Animas, bounded on the north by the Rio Las Animas, on the south and east by the line of the original city limits, and on the westerly side by the easterly line of ward two, as by the ordinance established.
