MINUTES FOR THE BONNER COUNTY BOARD OF COMMISSIONERS' MEETING

January 23, 2018 – 9:00 A.M. Bonner County Administration Building 1500 Hwy 2, Ste. 338, Sandpoint, ID

On Tuesday, January 23, 2018 the Bonner County Commissioners met for their regularly scheduled meeting with all three Commissioners present. Chairman Bailey called the meeting to order at 9:00 a.m. The Invocation was presented by Chad Wilkes of the Church of the Nazarene and the Pledge of Allegiance followed.

ADOPT ORDER OF THE AGENDA

Commissioner McDonald moved to approve the agenda as presented. Commissioner Connolly seconded the motion. All in favor. The motion passed.

1) Discussion/Decision Regarding Marine Vessel Reserve Fund for IDPR WIF Grant Application for the purchase of two (2) replacement outboard engines; County Match \$14,796.00

Commissioner McDonald moved to approve the Idaho Department of Parks and Recreation WIF Grant Application Request in the amount of \$22,000.00 and allow the chairman to sign. This Grant is for the purchase of outboard replacement engines for a vessel that patrols the waterways, and it requires a County Match in the amount of \$14,796.00. Commissioner Connolly seconded the motion. There was a brief discussion amongst the Audience and Ed Jochum and the Board regarding this application. All in favor. The motion passed.

2) Discussion/Decision Regarding Marine Vessel Reserve Fund for IDPR WIF Grant Application for the purchase of one (1) replacement outboard engine; County Match \$10,000.00

Commissioner Connolly moved to approve the Idaho Department of Recreation WIF Grant Application request in the amount of the Idaho Department of Parks and Recreation WIF Grant Application Request in the amount of \$14,761.00 and allow the chairman to sign. This Grant is

for the purchase of a replacement outboard engine for a vessel that patrols the waterways, and it requires a County Match in the amount of \$10,000.00.
