March 20, 2018 – 9:00 A.M. Bonner County Administration Building 1500 Hwy 2, Suite 338, Sandpoint, ID

On Tuesday, March 20, 2018 the Bonner County Commissioners met for their regularly scheduled meeting with all two Commissioners present, Commissioner Connolly was excused. Chairman Bailey called the meeting to order at 9:00 a.m. The Invocation was presented by Dave Elliott and the Pledge of Allegiance followed.

ADOPT ORDER OF THE AGENDA
