- 2) Discussion/Decision Regarding Budget Adjustment Unanticipated Revenue Highway Users Fund; \$490,589.48; **Resolution**

Commissioner McDonald made a motion to approve Resolution 18 - 54, authorizing the Clerk to open the Road and Bridge FY2018 budget and schedule revenue by increasing account 002-8760 Contracts-Roads by \$490,589.48 from \$310,923 to \$801,512.48. Commissioner Connolly seconded the motion. All in favor. The motion passed.

## SHERIFF - Daryl Wheeler

Discussion/Decision Regarding Idaho State Department of Agriculture Agreement; \$123,165.00 Commissioner Connolly made a motion to approve the agreement with the Idaho State Department of Agriculture (ISDA) and Bonner County Sheriff's Office to provide law enforcement services. The ISDA will reimburse Bonner County \$123,165.00 dollars with the agreement being effective from May 4, 2018 and can be terminated by ISDA if the Legislature fails, neglects, or refuses sufficient funds. Commissioner McDonald seconded the motion. All in favor. The motion passed.

#### **RECREATION** – James Shannon

 Discussion/Decision Regarding Garfield Bay Campground Host Contract; \$340 Per Week Springtime, \$440 per Week Summertime

Commissioner McDonald made a motion to approve the 2018 Garfield Bay Campground Host contract naming Ron Heikkila as the Campground Host. The contract will pay \$340 per week for the first five weeks and then \$440 per week for the remaining ten weeks, providing coverage from Memorial Day through Labor Day. Commissioner Connolly seconded the motion. All in favor. The motion passed.
