MINUTES FOR THE BONNER COUNTY BOARD OF COMMISSIONERS' MEETING

July 10, 2018 – 9:00 A.M. Bonner County Administration Building 1500 Hwy 2, Suite 338, Sandpoint, ID

On Tuesday, July 10, 2018 the Bonner County Commissioners met for their regularly scheduled meeting with Commissioners Bailey, McDonald & Connolly present, and Chairman Bailey called the meeting to order at 9:00 a.m. The Invocation was presented by Patsor Jon Pomeroy and the Pledge of Allegiance followed.

ADOPT ORDER OF THE AGENDA

Commissioner Connolly moved to adopt the order of the agenda as presented. Commissioner McDonald seconded the motion. All in favor. The motion passed.

1) Action Item: Discussion/Decision Regarding Professional Services Agreement, Amendment #1, Priest River Airport, Grant Administration Tasks with T-O Engineers, Inc; \$7,152.50 Commissioner Connolly made a motion to approve and sign the first amendment to the professional services contract with T-O Engineers and that the Chairman sign the amendment administratively. Commissioner McDonald made a motion to approve the Memorandum of Agreement to Support Clinical Services in Juvenile Detention Facilities. This Memorandum of Agreement sets forth the conditions under which the Idaho Department of Juvenile Corrections provides funding in the amount of Thirty Thousand (\$30,000.00) Dollars for the 2018/2019 fiscal year to pay part of the salary paid to the Detention Clinician

employed in the Bonner County Juvenile Detention Center and has been approved by legal. Commissioner Connolly seconded the motion. All in favor. The motion passed.

PROSECUTOR - Scott Bauer

1) Action Item: Discussion/Decision Regarding Statutory Reserve Appropriation to Civil Litigation; **Resolution**

Commissioner Connolly made a motion to approve Resolution #18-80 authorizing the Clerk to open the Justice Fund Statutory Reserve Budget and decrease line item 034127860 miscellaneous expense by \$55,000.00 from \$826,575.00 to \$771,575.00 and open the Justice Fund Civil Litigation budget and increase line item 03471-7200 Miscellaneous Litigation, by \$55,000 from \$105,000 to \$155,000. Commissioner McDonald seconded the motion. All in favor. The motion passed.
