On 07/28/2015 at approximately 1515 hours, Officers responded to the 3000 block of Denali Avenue due to a disturbance at that location. When Officers arrived they learned there was an altercation between a male and female at the residence. Based on evidence at the scene, Joseph Hostetler, age 20, was arrested for Assault in the Fourth Degree-Domestic Violence. He was transported to the State Jail and held without bail.

On 7/28/2015 at approximately 2146 hours, Officers conducted a traffic stop in the 4800 block of North Tongass Highway. Officers found the driver, Sara White, age 28, did not have insurance for the vehicle. Ms. White was cited for Motor Vehicle Insurance Required.
