On 7/21/2015 at approximately 1935 hours, Officers conducted a traffic stop on a vehicle in the 300 block of Bawden Street and contacted the driver, Mikel Dupree, age 26. Mr. Dupree was found not to have a valid operator's license in the State of Alaska. He was cited for No Valid Operator's License.

On 7/21/2015 at approximately 2127 hours, Officers contacted Christine Ramey, age 50, who was in an argument and appeared very intoxicated. Ms. Ramey was warned not to enter a bar or liquor store for the evening. At approximately 2346 hours, Officers contacted Ms. Ramey in a bar in the 300 Block of Front Street. Ms. Ramey was charged with Drunk on Licensed Premises. She was transported to the State Jail and released on her own recognizance.

On 7/22/2015 at approximately 0313 hours, Officers responded to a Front Street hotel due to a report of a male walking around, wearing only a t-shirt. Officers contacted Marcel Lichtenstein, age 46, naked from the waist down. Mr. Marcel was charged with Indecent Exposure in the Second Degree. He was transported to the State Jail and released on his own recognizance.

On 7/22/2015 at approximately 2007 hours, Officers responded to an apartment in the 600 block of Park Avenue, due to an intoxicated female refusing to leave. Officers contacted Anna Peratrovich, age 64, who refused to leave after being warned by Officers. Ms. Peratrovich was charged with Criminal Trespass. She was transported to the State Jail and released on her own recognizance.

On 7/22/2015 at approximately 2315 hours, Officers responded to the area below the parking garage of a Bawden Street apartment complex due to a report of a possible sexual assault. Officers contacted the victim and the suspect Melvin Guthrie Sr., age 50, who is a registered sex offender. Based on the investigation, Mr. Guthrie was charged with Sexual Assault in the First Degree. Mr. Guthrie was transported to the State Jail and held without bail.

On 7/25/2015 at approximately 1228 hours, Officers responded to 800 block of Buren Road due to a report of a domestic disturbance. The investigation showed Simon Milne, age 34, assaulted a household member and fled the area on foot. At approximately 2258 hours, Officers with the assistance of the Alaska State Troopers, executed a search warrant on an apartment in the 1400 Block of Tongass Avenue. Officers contacted Mr. Milne and took him into custody. Mr. Milne was charged with Assault in the Third Degree. During the search of the residence, the home owner, identified as Clara Natkong, age 63, became combative with the arresting Officers. Ms. Natkong was

charged with Hindering Prosecution and Assault in the Third Degree against a Law Enforcement Officer. Both were transported to the State Jail and held without bail.

On 7/25/2015 at approximately 1300 hours, Officers contacted David Anniskette, age 18, who drove up to officers at the scene of another call. Mr. Anniskette's driver's license was found to be revoked in the State of Alaska. He was cited for Driving While License Revoked.

On 7/26/2015 at approximately 0938 hours, Officers contacted Jacob Adler, age 18, in the 1400 block of Tongass Avenue due to a report of a suspicious male. Mr. Adler was on probation which states he cannot consume alcohol. Mr. Adler was taken into custody. He was transported to the State Jail and held without bail.
