On 6/27/2015 at approximately 2147 hours, Officers responded to a local restaurant to a report of a male who failed to pay for his meal. Officers contacted Michael Peterson Sr., age 53. Mr. Peterson was charged with Theft in the Fourth Degree. He was transported to the State Jail and released on his own recognizance.

On 7/1/2015 at approximately 2206 hours, Officers responded to the bus stop in the 600 block of Stedman Street to a report of a fight. The investigation showed Paul Gobel, age 49, struck another male in the face with a glass bottle, shattering it. Mr. Gobel was charged with Assault in the Third Degree.
