On 06/11/2015 at approximately 2300 hours, Officers received a complaint about an intoxicated male leaving a Water Street bar and driving away. Officers conducted a traffic stop on the vehicle and contacted the driver Larry Brooks, age 61. Mr. Brooks appeared intoxicated and failed field sobriety tests. Mr. Brooks was charged with Driving Under the Influence. He was transported to the State Jail and released on his own recognizance.
