On 6/4/2015 at approximately 1240 hours, Officers contacted John Jametski, age 57, at a west end apartment building during an unrelated investigation. Mr. Jametski was arrested for an outstanding arrest warrant. He was charged with Assault in the Third Degree. He was transported to the State jail and held without bail. The charge stems from a May 2015 case.

On 6/5/2015 at approximately 1201 hours, Officers contacted Alper Stovall, age 54, in the 600 block of Stedman Street. Mr. Stovall was arrested on an outstanding warrant. He was transported to the State Jail and held without bail.
