On 5/13/2015 approximately 1844 hours, Officers responded to the Ketchikan Apartments to a report of a possible assault. Officers contacted Jasmine Booth, age 31, who was charged with Assault in the Fourth Degree-Domestic Violence. When Officers attempted to place Ms. Booth in custody, she kicked and punched both Officers and was actively fighting with Police. Ms. Booth was placed in restraints and charged with two additional counts of Assault in the Fourth Degree on a Peace Officer and one count of Resisting Arrest. Ms. Booth was transported to the State Jail and held without bail.

On 5/13/2015 at approximately 2039 hours, Officers responded to a west end grocery store due to a report of a male shoplifter in custody. Derek Holzwart, age 42, was found to have left the store with food he did not pay for. Mr. Holzwart was charged with Theft in the Fourth Degree. He was transported to the State Jail and released on his own recognizance.

On 5/13/2015 at approximately 2330 hours, Officers responded to a report of a male who had become violent on the 600 block of Adams Street. Officers contacted Brian Kenyon, age 41, who punched through two windows and shattered a third window with a dumb bell. Mr. Kenyon was charged with Criminal Mischief in the Third Degree-Domestic Violence. He was transported to the State Jail and held without bail.

On 05/14/2015 at approximately 1547 hours, Officers contacted Donovan Weston, age 20, in the 800 block of Water Street due to a report of a possible assault. Mr. Weston was found to have conditions of probation which state he is not to consume alcohol. Mr. Weston appeared to be intoxicated. Mr. Weston was arrested for Violating Conditions of Probation and cited for Minor Consuming Alcohol. He was transported to the State Jail and held without bail.

On 05/15/2015 at approximately 1838 hours, Officers contacted James Demmert, age 54, on East Street after observing him drinking from an open container of alcohol. Mr. Demmert was found to have conditions of release which state he is not to consume alcohol. Mr. Demmert was charged with Violating Conditions of Release. He was transported to the State Jail and held on \$500 bail.

On 5/17/2015 at approximately 2317 hours, Officers responded to a residence in the 400 block of Main Street to a report of a male trespassing. Officers contacted the caller Ramon Martinez, age 38. Mr. Martinez was found to have conditions of release not to consume alcohol. Mr. Martinez appeared intoxicated. Mr. Martinez was charged with Violating Conditions of Release. He was transported to the State Jail and held on \$2000.00 bail.

On 5/18/2015 at approximately 2245 hours, Officer conducted a traffic stop on a vehicle in the 300 block of Front Street. Lee Grierson, age 46, was contacted as the driver. Mr. Grierson's driver's license showed him to have a current restriction which requires him to have an Interlock Ignition Device installed in his vehicle. The vehicle he was operating did not have the required device installed. Mr. Grierson cited for Avoidance of Interlock Ignition Device.

On 5/19/2015 at approximately 0900 hours, Officers responded to a residence on Austin Street to a report that Robert Lett, age 68, had a machete and was pointing it at a female. Based on the investigation, Mr. Lett was charged with Assault in the Third Degree. He was transported to the State Jail and held without bail.

On 5/21/2015 at approximately 1008 hours, Officers responded to the 400 block of Schoenbar Road to a report of possible assault. Officers contacted Jack Alexander, age 51, who was found to have assaulted his girlfriend. Mr. Alexander was charged with Assault in the Fourth Degree-Domestic Assault. He was transported to the State Jail and held without bail.

On 05/21/2015 at approximately 1355 hours, Officers contacted on Michael Baham, age 34, in the 300 block of Schoenbar Road. He was served a summons to appear in court, charging him with Driving While License Revoked. The summons stems from an April 2015 case.
