On 4/28/2015 at approximately 0123 hours, Officers responded to an apartment in the 600 block of Park Avenue due to a report of a female breaking into a residence and assaulting the tenant. Officers contacted Michalyn McAlpin, age 49, who forced the door open to another tenant's residence and tried to assault him. The victim grabbed a pocket knife to defend himself. She also broke a window in the apartment she was renting. Ms. McAlpin was charged with Burglary in the First Degree, Assault in the Fourth Degree and Criminal Mischief in the Fourth Degree. She was transported to the State Jail and held on no bail.

On 04/28/2015 at approximately 2345 hours, Officers conducted a traffic stop on a vehicle near the intersection of Third Avenue and Washington Street. Shasta Sutton, age 30, was contacted as the driver. Ms. Sutton's driver's license was found to be suspended in the State of Alaska. She was cited for Driving While License Suspended.
