On 3/22/2015 at approximately 2013 hours, Officers responded to a residence in the 2300 block of First Avenue due to a report of a domestic disturbance. The investigation showed Kaila Delrosario, age 18, assaulted her roommate. Ms. Delrosario was charged with Assault in the Fourth Degree-Domestic Violence, and cited for Minor Consuming Alcohol. She was transported to the State Jail and held without bail.

On 3/23/2015 at approximately 0310 hours, Officers responded to the area of the 600 block of Deermount Street due to a report of a verbal dispute. Officers contacted Ethan Bolton, age 25, whose vehicle was parked in the roadway. Mr. Bolton appeared intoxicated and failed field sobriety tests. Ms. Bolton's driver's license is suspended in the State of Alaska. Mr. Bolton later refused to provide a breath sample. Mr. Bolton was charged with Driving Under the Influence, Driving While License Suspended and Refusal to Submit To a Chemical Test. He was transported to the State Jail and released on his own recognizance.

On 3/23/2015 at approximately 1721 hours, Officers saw Paul Goble, age 48, drinking a beer in the 400 block of Stedman Street. When officers contacted Mr. Goble, Anna Peratrovich, age 63, was sitting next to him. Ms. Peratrovich began drinking from an open 40 ounce bottle of beer in front of the Officer. Mr. Goble has conditions of release which state he is not to violate any laws. Mr. Goble was charged with Violating Conditions of Release. Ms. Peratrovich was charged with Disorderly Conduct-Open Container. They were transported to the State Jail. Mr. Goble was held on \$500.00 bail. Ms. Peratrovich was released on her own recognizance.

On 03/24/2015 at approximately 1014 hours, Officers observed a male identified as Eugene Estes III, age 39, urinating on the promenade at East Street. Officers also observed Mr. Estes with an open container of alcohol. Mr. Estes was charged with Disorderly Conduct-Urinating in Public and Disorderly Conduct-Open Container. He was transported to the State Jail and released on his own recognizance.

On 3/24/2015 at approximately 0927 hours, Officers contacted Lapairs Shaw, age 23, in the 1200 block of Schoenbar Road. Mr. Shaw was arrested for an outstanding warrant. He was transported to the State Jail and held on \$1,000.00 bail.

Ms. Culbertson appeared to be intoxicated. Ms. Culbertson has conditions of release which state she is not to consume alcohol. She was charged with Violating Conditions of Release. She was transported to the State Jail and held on \$500.00 bail.

On 3/24/2015 at approximately 1948 hours, Officers contacted Ryan Brandt, age 30, in the lobby of the Police station. Mr. Brandt had a warrant and wanted to turn himself in. He appeared to be intoxicated. He has conditions of release which state he is not to consume alcohol. He was arrested for an outstanding warrant and charged with Violating Conditions of Release. He was transported to the State Jail and held on \$1000.00 bail.
