On 3/16/2015 at approximately 1707 hours, Officers observed a male and female identified as Paul Goble, age 48, and Margaret Milton, age 53, with open containers of alcohol on East Street. Both subjects were cited for Disorderly Conduct-Open Container.

On 03/17/2015 at approximately 1013 hours, Officers contacted Jason French, age 43, riding a motorized bicycle in the 2400 block of Tongass Avenue. French had a suspended driver's license out of California and was charged with Driving While License Suspended. Mr. French was transported to the State Jail and released on his own recognizance.

On 3/17/2015 at approximately 1220 hours, Officers observed Rebecca Culbertson, age 33, enter the Totem Bar after being previously warned not to enter any bars due to her level of intoxication. Ms. Culbertson has condition of release not to violate any local or state laws. Officers contacted Ms. Culbertson inside the bar and she was charged with Drunk on Licensed Premise and Violating Conditions of Release. She was transported to the State Jail and held on \$500.00 bail.

On 03/17/2015 at approximately 1248 hours, Officers observed two males with open containers of alcohol on the promenade at East Street. The males were identified as Paul Haisler, age 22, and Hollis Hayes, age 42. Both subjects were charged with Disorderly Conduct-Open Container. They were transported to the State Jail. Mr. Hayes was released on his own recognizance and Mr. Haisler was held on \$100 bail.

On 3/17/2015 at approximately 1702 hours, Officers responded to the 800 block of Water Street for a report of a male subject in need of aid. Officers contacted two juvenile males age 14 and 17. The 14 year old male was found to be intoxicated. He was cited for Possession of Alcohol by Person Under 21 and was released to his father. The 17 year old male was found to be a runaway and while officers were taking him into custody, found three knives hidden on his person. He was released to his aunt and a charge of Misconduct Involving Weapons in the Fifth Degree which was forwarded to Juvenile Probation.

On 3/18/2015 at approximately 1504 hours, Officer conducted a traffic stop on a vehicle in the 1400 block of Fairy Chasm. Kristy Shields, age 35, was contacted as the driver. Ms. Shields's driver's license is suspended in the State of Alaska and she has conditions of release not to drive and to obey all laws.
