On 3/12/2015 at approximately 0815 hours, Officers were dispatched to report of a domestic dispute on the 3800 block of Evergreen Avenue. Zachary Nebl, age 23, had broken the rear window of his father's pickup truck. Mr. Nebl was arrested for Criminal Mischief in the Fourth Degree-Domestic Violence and Violating Conditions of Release. He was transported to the State Jail and held without bail.

On 3/13/2015 at approximately 1040 hours, Officers responded to an apartment on Dock Street due to a report of an assault. Nicole Durgan, age 33, was charged with Assault in the Fourth Degree. She was transported to the State Jail and held on \$1,000.00 bail.

On 3/13/2015 at approximately 1645 hours, Officer contacted Donna Anderson, age 44, at a bus stop on Stedman Street due to a report of an intoxicated female falling in the road. Ms. Anderson was taken into protective custody and transported to the local hospital. Ms. Anderson became violent while at the hospital. Ms. Anderson was charged with Disorderly Conduct-Violent and Tumultuous. She was transported to the State Jail and released on her own recognizance.

On 3/15/2015 at approximately 1136 hours, Officers served a summons on Chaz K. Niemi, age 19, ordering him to appear in court. He was charged with Driving Under the Influence. The charge stems from a traffic collision which occurred in November 2014 where he was suspected to be under the influence of controlled substances.

On 3/16/2015 at approximately 0834 hours, Officers contacted Peter Cochran, age 39, near a South Yorktown residence hiding in a shed. He was arrested for an outstanding warrant. He was transported to the State Jail and held on \$5,000.00 bail.

On 3/16/2015 at approximately 1040 hours, Officers executed a search warrant in the 800 block of Buren Road. Daniel J. O'Sullivan, age 32, and Krista Michels, age 28, were charged with Violating Conditions of Release. They were transported to the State Jail and held on \$2,000.00 each.
